Landscaping Project

At the annual homeowners meeting in December, it was agreed to that the islands in the development needed landscaping work. After gathering information and quotes from multiple vendors, homeowners were notified about the upcoming landscaping of the main round about and the other three community islands. Everyone was given an opportunity to vote on one of four proposed options via email or paper ballot. Unfortunately, we only received a total of 19 votes (including the 3 board member votes). For those who provided feedback, thank you very much! For everyone else, I hope to catch you next time. Here are the results of those votes:

Option 1: 5 votes Option 2: 1 vote

Option 3: 2 votes Option 4: 11 votes

The board took into consideration the votes and is opting to modify the original plan (Option 1). The main change being that irrigation will no longer be pursued. The current plan will be to replace the mulch on the islands and seek additional drought resistant plantings to fill out the main island space. Community Awareness

Did you know that there were 616 larcenies in the city of Brooklyn Park from January through May of this year? This includes theft from an automobile. Unfortunately, the criminal element has reared its ugly head in our community recently. During the early morning of June 4th, there were several car burglaries in our development. However, they were stopped when a fellow neighbor (Rodger Coppa) contacted the authorities and notified them of two suspicious individuals driving around the development that morning.

This is an excellent example of what one should do when something appears out of the ordinary. Below are some tips to prevent theft from your automobile.

- Lock your car
- Do not leave valuables in your car including GPS units, change, gym bags, shopping bags, computers, purses, wallets......
- Park in well-lit areas
- Use a garage if it is available
